CONSTRUCTION DETAILS: The basic raw material in Homex 300 is 100% post-consumer wastepaper (with weather and termite-resistant additives). Homex 300 is lightweight, splinter free and easy to cut or shape. It is available in nominal 3/8", 1/2", 3/4" and 1" thickness, in lengths to 10' and widths from 3" to 48" (custom sizes available upon request). Homex 4' x 10' slabs can be fabricated into non-standard size strips or specified curb and gutter configurations.
